COMMERCIAL ITEM DESCRIPTION

PAPER, WRAPPING, TISSUE

The General Services Administration has authorized the use of this Commercial Item Description, for all Federal agencies.

Scope: This description covers tissue paper which is used for wrapping items to protect them from breaking, scratching or dust during shipment or storage.

<u>Classification</u>: The tissue paper covered by this Commercial Item Description shall be of the following types, as specified (See Section 6, Ordering Data).

Type I - regular
Type II - antitarnish

1. <u>FALIENT CHARACTERISTICS</u>:

- A. The tissue paper shall be 100 percent bleached chemical wood pulp and shall conform to the requirements in Table 1 when tested in accordance with paragraph 4.C.(3).
- B. Type II tissue paper shall not tarnish silver when tested in accordance with paragraph 4.C.(3).
- C. The tissue paper shall be furnished in sheets with clean cut edges. The dimensions shall be as specified \pm 6.4 millimeters (\pm 1/4 inch)

- D. Holes in the tissue paper greater than one square millimeter in area shall not total more than 8 square millimeters in a 64.5-centimeter square (10-inch square) sheet.

3. REGULATORY REQUIREMENT: The contractor shall certify that the product offered shall include a minimum of 5% postconsumer recovered materials, in accordance with 40 CFR, part 250. The Government reserves the right to require proof of such conformance prior to first delivery and thereafter as may be otherwise provided for under the provisions of the contract.

4. QUALITY ASSURANCE:

A. Responsibility for Inspection: Unless otherwise specified in the contract or purchase order, the supplier is responsible for the performance of all the inspection requirements of this CID. Except as otherwise specified, the supplier may utilize his own facilities

or any commercial laboratory acceptable to the Government. The Government reserves the right to perform any of the inspections set forth in the Commercial Item Description, where such inspections are deemed necessary to assure that supplies and services conform to prescribed requirements (See Section 6, Ordering Data).

- B. <u>Sampling</u>: All sampling shall be in accordance with MIL-STD-105 except in paragraph (3).
 - (1) <u>Sampling for Visual Inspection</u>. A random sample of tissue paper shall be taken from each lot. The inspection level shall be S-4 with an Acceptable Quality Level (AQL) of 4.0 percent defective. The sample unit shall be one sheet.
 - (2) <u>Sampling for Dimensional Inspection</u>. A random sample of tissue paper shall be taken from each lot. The inspection level shall be S-3 with an AQL of '4.0 percent defective. The sample unit shall be one sheet.
 - (3) <u>Sampling for Tests</u>. A random sample of tissue paper shall be taken from each lot. The inspection level and AQL percent shall be as per TAPPI T-400.
 - (4) <u>Sampling for Preparation for Delivery</u>. For examination of the preparation for delivery. The sample unit shall be one shipping container fully prepared for delivery, selected at random. The inspection level shall be S-2 with an AQL of 4.0 percent defective.

C. <u>Inspections</u>.

- (1) <u>Visual Examination</u>. Samples taken in accordance with paragraph 4.B.1. shall be examined to verify that the superficial product requirements are in compliance with Section 1.
- (2) <u>Dimensional Examination</u>. Samples taken in accordance with paragraph 4.B.2. shall be examined to verify that all dimensionally measurable product requirements are in compliance with Section 1.
- (3) <u>Tests</u>. Samples taken in accordance with paragraph 4.B.3. shall be subjected to the following tests to demonstrate consistency in product functionality, durability, and performance expectations.
 - (a) For basis weight use TAPPI test method T-410.
 - (b) For bursting strength use TAPPI test method T-403.

- (c) For tearing resistance use TAPPI test method T-414.
- (d) For acidity use TAPPI test method T-435.
- (e) Type II tissue paper shall not tarnish silver when tested using TAPPI T-444.
- (4) Examination for Preparation for Delivery. Samples taken in accordance with paragraph 4.B.4. shall be examined to determine compliance with Section 5.

5. PREPARATION FOR DELIVERY.

A. <u>Packaging and Packing Provisions</u>. Each ream (480 sheets) shall be packaged to prevent damage during multiple shipments, handling, and storage. Packaged tissue paper shall be packed in accordance with normal commercial practice. The packing container shall be closed to prevent accidental opening and shall be such to insure carrier acceptable and safe delivery to destination, complying with the rules and regulations applicable to the mode of transportation to be used. (See Section 6)

B. Marking.

- (1) For Shipment to Civilian Agencies. In addition to any special marking required by contract or order, marking shall be in accordance with Fed. Std. No. 123. Bar Code marking is required, unless otherwise specified (See Section 6).
- (2) <u>For Shipment to Military Activities</u>. In addition to any special markings required by the contract or order, marking shall be in accordance with MIL-STD-129. Bar Code marking is required, unless otherwise specified (See Section 6).
