COMMERCIAL ITEM DESCRIPTION

LAMP, INCANDESCENT, S-6, CANDELABRA SCREW

The General Services Administration has authorized the use of this commercial item description for all federal agencies.

1. **SCOPE.** This commercial item description (CID) covers S-6 incandescent lamps with a candelabra screw base. These lamps can be identified by the industry numbers specified in the notes section herein.

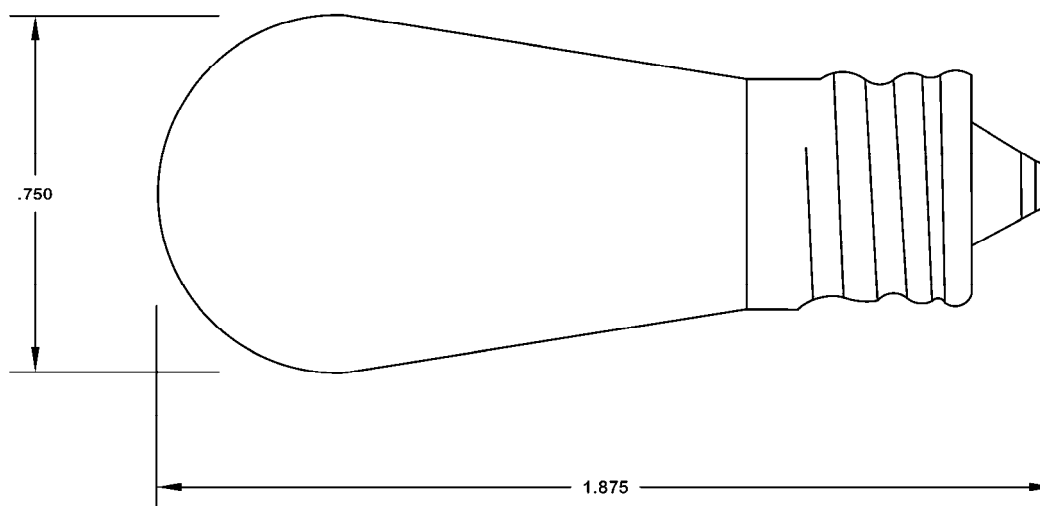
2. SALIENT CHARACTERISTICS

2.1 Physical characteristics. The lamps shall conform to figure 1 and the following physical characteristics:

Bulb designation	S-6
Bulb finish	Clear
Base designation	Candelabra screw
Filament type	(See functional characteristics)
Dimensions	(See figure 1)
