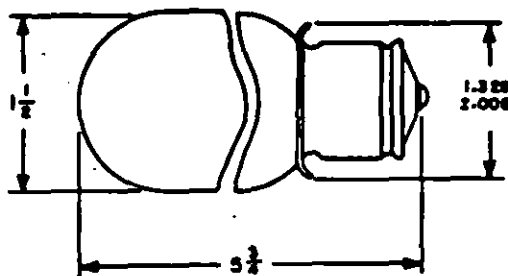
LAMP, INCANDESCENT, T-12,
MEDIUM PREFOCUSING, SINGLE CONTACT

The General Services Administration has authorized the use of this commercial item description as a replacement for MS15555 which is canceled.

Abstract. This commercial item description covers T-12 incandescent lamps with a single contact, medium prefocusing base. These lamps can be identified by industry numbers DDB and DFD.

Salient characteristics.1. Physical.

Burn Position	Base down
Bulb designation	T-12
Bulb finish	Clear, opaque coating on end
Base designation	Medium prefocusing, single contact
Filament types	C-13D
Light center length (distance from the center of the light source to the top of base pin)	2-3/16 inches
Dimensions	(See figure 1)
