COMMERCIAL ITEM DESCRIPTION

CHIGGER REPELLENT AND ANTIPRURITIC LOTION

The General Services Administration has authorized the use of this commercial item description for all federal agencies.

1. **SCOPE.** This commercial item description (CID) covers one grade of Chigger Repellent and Antipruritic Lotion, herein referred to as the lotion.

2. SALIENT CHARACTERISTICS.

2.1 **Composition.** The composition by weight of the lotion shall be $10.0 \pm 0.5\%$ United States Pharmacopeia (USP) grade Sublimed Sulfur and $3.0 \pm 0.3\%$ USP grade Benzocaine; with the remaining 87.0% being inert ingredients.

2.2 **Workmanship.** Lotion shall be free from defects which detract from its appearance or impair its serviceability.

3. REGULATORY REQUIREMENTS.

3.1 **Safety data sheet (SDS).** Manufacturers shall prepare and submit a SDS in accordance with FED-STD-313, "Material Safety Data, Transportation Data and Disposal Data for Hazardous Materials Furnished to Government Activities", and meeting the requirements of 29 Code of Federal Regulations § 1910.1200, "Occupational Safety and Health Standards: Hazard Communication".

3.2 **Marking, packaging, and labeling.** The lotion shall be labeled, packed and marked in accordance with 49 CFR parts 100 to 185.

3.3 Recovered materials. The offeror/contractor is encouraged to use recovered materials to the maximum extent practicable, in accordance with paragraph 23.403 of the Federal Acquisition Regulation (FAR).

3.4 Federal food, drug, and cosmetics act. If the lotion covered by this document has been determined by the U.S. Food and Drug Administration (FDA) to be under its jurisdiction, the offeror/contractor shall comply, and be responsible for the compliance by its subcontractors and suppliers, with the requirements as amended for Title 21 of the United States Code (USC) § 301 et seq. and regulations promulgated thereunder. In addition, the offeror/contractor shall comply, and be responsible for compliance by its subcontractors and suppliers, with the requirements of all other applicable federal, state, and local statutes, ordinances, and regulations.

3.5 Federal Insecticide, Fungicide and Rodenticide Act. The lotion shall conform to the Fungicide, and Rodenticide Act (FIFRA), 7 USC § 136 et seq., as amended in accordance with 40 CFR 162-280.

4. PRODUCT CONFORMANCE PROVISIONS.

4.1 Product conformance. The lotion provided shall meet the salient characteristics of this commercial item description, conform to the producer's own drawings, specifications, standards, and quality assurance practices, and be the same lotion offered for sale in the commercial market. Any certificate of analysis (COA) offered with the lotion to the commercial market shall be provided with each lot or batch of lotion. The lot or batch number and the date of inspection/analysis from the offer shall be on each COA. A full COA proving the salient characteristics of the lotion meets government requirements shall be provided upon request. The government reserves the right to require proof of such conformance.

4.2 Market acceptability. The lotion offered must have been sold to the Government or commercial market.

5. PACKAGING. Preservation, packing, and marking shall be as specified in the contract or order.

6.3 National stock number (NSN). NSN 6810-01-137-8456 corresponds to this CID. This may not be the only NSN associated with this document.

6.4 Shelf-life. This specification covers items where the assignment of a Federal shelf-life code is a consideration. Specific shelf-life requirements should be specified in the contract or purchase order, and should include, as a minimum, shelf-life code, shelf-life package markings in accordance with MIL-STD-129 or FED-STD-123, preparation of a materiel quality storage standard for type II (extendible) shelf-life items, and a minimum of 85 percent shelf-life remaining at time of receipt by the Government. These and other requirements, if necessary, are in DoD 4140.27-M, Shelf-life Management Manual. The shelf-life codes are in the Federal Logistics Information System Total Item Record. Additive information for shelf-life management may be obtained from DoD 4140.27-M, or the designated shelf-life Points of Contact (POC). The POC should be contacted in the following order: (1) the Inventory Control Points that manage the item and (2) the DoD Service and Agency administrators for the DoD Shelf-Life Program.
