# COMMERCIAL ITEM DESCRIPTION

### RUBBER, SILICONE; CHANNEL, NONMETALLIC, SHAPE 3

The General Services Administration has authorized the use of this Commercial Item Description for all Federal Agencies.




Figure 1. Dimensional and physical requirements.

- 1. SCOPE. This commercial item description (CID) covers a silicone rubber nonmetallic channel, shape 3 (see figure 1).
- 2. CLASSIFICATION. The silicone rubber shall be of the following classes and grades as specified. The designated grade number corresponds to the nominal Shore Durometer A hardness value.

Class 1A – Low temperature resistant Grade – 40, 50, 60, 70, and 80

Class 1B – Low temperature resistant and low compression set at high temperature Grade – 40, 50, 60, 70, and 80

Class 2A – High temperature resistant Grade – 25, 40, 50, 60, 70, and 80

Class 2B – High temperature resistant and low compression set

Grade - 25, 40, 50, 60, 70, and 80

Class 3A – Low temperature, tear and flex resistant Grade – 30. 50. and 60

None 2D Took and flow register

Class 3B – Tear and flex resistant Grade – 30, 50, 60, 70, and 80

# 3. SALIENT CHARACTERISTICS.

3.1 <u>Dimensional and physical requirements</u>. Dimensional and physical requirements shall conform to figure 1. Dimensional tolerance shall conform to the applicable commercial tolerance specified in CID A-A-59588.

Notes: 1. Dimensions are in inches.


- 3.2 <u>Material</u>. Material shall be silicone rubber formulated and processed to meet the physical and mechanical properties per the specified class and grade, when tested in accordance with ASTM test methods specified in Table I of CID A-A-59588.
- 3.3 <u>Color</u>. Unless otherwise specified, the color of the silicone rubber shall be the natural color of the compound furnished.
- 3.4 <u>Workmanship</u>. The end product shall be clean, smooth finished, and free from dirt, flash or rough edges.
- 3.5 <u>Metric products</u>. Products manufactured to metric dimensions will be considered on an equal basis with those manufactured using inch-pound units, provided they fall within specified tolerances using conversion tables contained in the latest revision of ASTM SI 10, and all other requirements of this commercial item description are met. If a product is manufactured to metric dimensions and those dimensions exceed the tolerances specified in the inch-pound units, a request should be made to the contracting officer to determine if the product is acceptable.
- 4. REGULATORY REQUIREMENTS. The offeror/contractor is encouraged to use recovered materials to the maximum extent practicable, in accordance with paragraph 23.403 of the Federal Acquisition Regulation (FAR).

#### 5. PRODUCT CONFORMANCE.

5.1 <u>Product conformance</u>. The products provided shall meet the salient characteristics of this commercial item description, conform to the producer's own drawings, specifications, standards, and quality assurance practices, and be the same product offered for sale in the commercial market. The government reserves the right to require proof of such conformance.
