
COMMERCIAL ITEM DESCRIPTION

FUSEHŐLDER, BLOCK, GENERAL REQUIREMENTS FOR

The General Services Administration has authorized the use of this commercial item description (CID) for all federal agencies

- 1 SCOPE This CID, covers the general requirements for fuseholder blocks. Requirements for specific fuseholder blocks are covered in the individual CID sheets. Fuseholder blocks covered by this CID are intended for commercial/industrial applications.
- 2 CLASSIFICATION This CID uses a classification system which is included in the Part Identification Number (PIN) as shown in the following example (see 6.1)



- 3 SALIENT CHARACTERISTICS
- 3.1 <u>Design and construction</u> Fuseholder blocks supplied to this CID shall be as specified on the applicable CID sheet
- 3.2 <u>Marking</u> Fuseholder blocks supplied to this CID shall be marked with the manufacturer's standard commercial PIN

4 QUALITY ASSURANCE PROVISIONS

- 4.1 <u>Contractor certification</u> The contractor shall certify and maintain substantiating evidence that the product offered meets the salient characteristics of this CID, and that the product conforms to the producer's own drawings, specifications, standards, and quality assurance practices, and is the same product offered for sale in the commercial marketplace. The Government reserves the right to require proof of such conformance prior to first delivery and thereafter as may be otherwise provided for under the provisions of the contract.
- 4.2 <u>Market acceptability</u> The following market acceptability criteria are necessary to document the quality of the product to be provided under this CID
 - a The company producing the item must have been producing a product meeting the requirements of this CID for at least 2 years
 - b The company must have sold 1000 units meeting this CID in the commercial marketplace over the past 2 years
- 5 PACKAGING
- 5.1 <u>Preservation, packing, and marking</u> Preservation, packing, and marking shall be as specified in the contract or order
- 6 NOTES
- 6.1 <u>PIN</u> The PIN should be used for Government purposes to buy commercial products to this CID. See 2 for PIN format example
- 6.2 <u>CAGE code</u> For ordering purposes, inventory control, and submission of these instruments to DESC under the Military Parts Control Advisory Group (MPCAG) evaluation program, CAGE code 58536 should be used
- 6.3 Source of documents This section is not applicable to this CID
- 6.4 Ordering data The contract or order should specify the following
 - a CID document number, revision, and CID PIN
 - b Quality assurance provisions
 - c If a bid sample is required
 - d Packaging requirements
