1. SCOPE. This commercial item description covers technical grade chromium trioxide, Chemical Abstract Service Registry Number (CAS #)1338-82-0.

2. CLASSIFICATION. The chromium trioxide shall conform to the following types (see 7.2):

Type I - Flake Type II - Crystalline

3. SALIENT CHARACTERISTICS. When tested using the methods and procedures of the American Chemical Society (ACS), "Reagent Chemicals, American Chemical Society Specifications," the chromium trioxide shall meet the specifications of table 1. No more that 30 percent (by weight) of the type I, flake chromium trioxide, shall pass through 600 μ m (No.30) sieve conforming to ASTM E11. No more that 30 percent (by weight) of the type II, crystalline chromium trioxide, shall pass through 420 μ m (No.40) sieve conforming to ASTM E11.


