CAP LUBRICATION FITTING

The General Services Administration has authorized the use of this commercial item description for all federal agencies.

1. **SCOPE.** This CID covers the general requirements for Lubrication Fitting Caps. Caps covered by this CID are intended for commercial/industrial applications.
2. **CLASSIFICATION.** This CID uses a classification system which is included in the Part Identification Number (PIN) as shown (see 7.1).

3. SALIENT CHARACTERISTICS.

3.1 Dimensions. Cap(s) supplied to this CID shall be as specified herein and figure 1.

3.2 Material. The material shall conform to ASTM D4976, Group 2, Class 3 or 4.

3.3 Marking. Cap(s) supplied to this CID shall have the manufacturer's (MFR's) standard commercial part number and this CID PIN marked as specified in the contract or order (see 7.4).

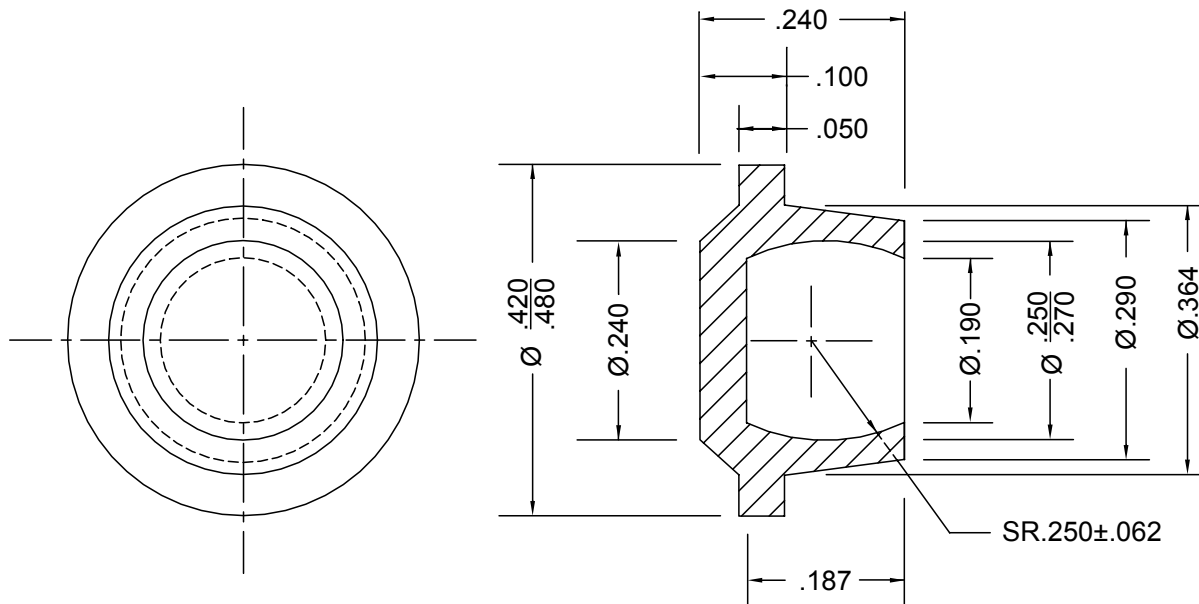

7. NOTES.

7.2 Commercial and Government Entity (CAGE) code. For ordering purposes, inventory control, and submission of these caps to DSCC under the Military Parts Control Advisory Group (MPCAG) evaluation program, CAGE code 58536 should be used.
