### COMMERCIAL ITEM DESCRIPTION

# WIPES, DISINFECTING

The General Services Administration has authorized the use of this commercial item description for all federal agencies.

- 1. SCOPE. This commercial item description (CID) covers disposable, disinfecting, alcohol-free, pre-moistened wipes.
- 2. SALIENT CHARACTERISTICS.
- 2.1 <u>General</u>. The wipes shall be alcohol-free and be ready-to-use (RTU) in a wipe dispenser that does not require original equipment manufacturer (OEM) specific refills.
- 2.2 <u>Prohibited materials</u>. The wipes shall not contain any materials above the threshold for trace amount that have a severity category of either catastrophic or critical in the prohibited and restricted chemicals tables in the NAVSEA List of Targeted Chemicals (N-LTC) appendix of T9070-AL-DPC-020/077-2, NAVSEA Hazardous Material Avoidance Process. The threshold for trace amount is defined as less than 1 percent for non-carcinogenic compounds and less than 0.1 percent for carcinogenic compounds.
- 2.3 <u>Volatile organic compound (VOC) levels</u>. VOC levels of the wipes shall be stated as a percent of VOCs by weight when prepared in the dilution ratio as directed on the manufacturer's label and shall not exceed the California Air Resources Board (CARB) 17 CCR § 94509 VOC standard for disinfectants.
- $2.4\,$  pH. The pH of the wipes shall be a minimum of  $5.0\,$  and a maximum of  $8.0\,$  when tested in accordance with ASTM E70.
- 2.5 Flash point. The flash point shall be greater than 93.3 °C (200 °F) when tested in accordance with ASTM D56.
- 2.6 <u>Eutrophication and phosphate</u>. The wipes shall comply with the U.S. Environmental Protection Agency (EPA) Safer Choice Standard eutrophication and phosphate criteria.
- 2.7 <u>Aquatic toxicity</u>. The wipes shall not be toxic to aquatic life in accordance with the United Nations Economic Commission for Europe (UNECE) Globally Harmonized System of Classification and Labelling of Chemicals (GHS) criteria for acute and chronic aquatic toxicity. More specifically, the wipes shall not have an acute toxicity within GHS Categories 1 and 2 for short-term (acute) aquatic hazard, and shall not have a chronic toxicity within GHS Categories 1 and 2 for long-term aquatic hazard.
- 2.8 <u>Efficacy</u>. The wipes shall pass efficacy tests of disinfectants against Staphylococcus aureus, Pseudomonas aeruginosa, and Salmonella enterica on hard surfaces per U.S. EPA Standard Operating Procedure (SOP) for Disinfectant Towelette Test Against Staphylococcus aureus, Pseudomonas aeruginosa, and Salmonella enterica (SOP Number: MB-09-05).

- 3.1 <u>Recovered materials</u>. The offeror/contractor is encouraged to use recovered materials to the maximum extent practicable, in accordance with paragraph 23.403 of the Federal Acquisition Regulation (FAR).
- 3.2 <u>FDA compliancy</u>. In order to be safely used on food contact surfaces, the wipes shall comply with all specifications and conditions described in 21 CFR 178.1010, Food and Drug Administration, Department of Health and Human Services Regulations for Indirect Food Additives: Adjuvants, Production Aids, and Sanitizers Table Subpart B Substances Utilized to Control the Growth of Microorganisms Sanitizing Solutions.
- 3.3 <u>Registering and labeling</u>. The wipes shall be registered and labeled in compliance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), 7 U.S.C. § 136, et seq., as amended in accordance with 40 CFR 162-280. The containers shall be labeled with contents and directions for use in accordance with the 40 CFR 156-157.
- 4. PRODUCT CONFORMANCE PROVISIONS. The products provided shall meet the salient characteristics of this CID, conform to the producer's own drawings, specifications, standards, and quality assurance practices, and be the same product offered for sale in the commercial marketplace. The government reserves the right to require proof of such conformance.
- 5. PACKAGING. Preservation, packing, and marking shall be as specified in the contract or order.
