Block 7, Application/Interrelationship (Continued)

7.3 It is applicable to contracts for acquisition of items via a military specification, prepared in accordance with MIL-STD-961, where it is necessary to specify detailed technical content requirements. It should be used in lieu of DI-MISC-80296 for these types of contracts.

7.4 The applicable military specification containing the technical content for the design data and calculations shall be stated in Block 16 of the DD Form 1423, Contract Data Requirements List.
