10 PREPARATION INSTRUCTIONS 10.1 <u>Format</u> . The Logistic Support Analysis Record (LSAR) Pricing Plan shall be organized into three major sections. The LSAR Pricing Plan shall be typed or printed on white bond paper. Pages shall be 8 1/2 by 11 inches and shall be punched suitable for binding in a three-ring loose leaf binder. 10.2 <u>Content</u> . The LSAR Pricing Plan shall consist of three major sections in accordance with the following instructions: 10.2.1 <u>Section 1. - General</u> . This section shall contain the following: a. Purpose and Scope. A concise statement of the scope and intended purpose. b. Assumptions. State any assumptions used. c. Updating Process. A description of how changes and revisions of the date will be developed, approved, and incorporated. d. Summary. A concise description sufficient to establish a clear understanding of the total scope and content of the material presented. (Continued on Page 2)

Block 10 Preparation Instructions (Continued)

10.2.2 Section 2. - Pricing Methodology. This section shall provide a description of the contractor methodology for determining unit of measure prices for "P" source-coded item(s) to be entered into the LSAR data base. The contractor methodology shall include the following:

10.2.2.1 Pricing Data.

- a. Pricing of purchase finished or manufactured part(s).
- b. Pricing of in-house manufactured part(s).
- c. Pricing of combination purchase or in-house manufactured part(s).

10.2.2.2 Prices. The pricing data shall be sub-divided to address prices as follows:

- a. "Prices" - Cited in the Defense Logistics Services Center (DLSC) files.
- b. "Prices" - When no NSN is contained in the DLSC files.

10.2.2.3 Computation. The unit of measure prices shall be based on the most economical of the following:

- a. Minimum economical production quantity.
- b. Contractor's recommended one year's initial support.

10.2.3 Section 3. - LSAR Pricing Plan, Management, and Execution. This section shall provide a complete description of the overall process that will be used in managing and executing the LSAR Pricing Plan including both the required Government and contractor participation.
