- 10.2.13 Item 13 - ROUTING IDENTIFIER CODE-FROM (CC 67-69). Routing Identifier Code of the contractor submitting this transaction. To be specified in the contract when required.

- 10.2.15 Item 15 - CONDITION CODE (CC 71). Classification of materiel denoting degree of serviceability condition, and completeness in terms of readiness for issue. Appropriate condition code of item for which count or balance is submitted.
- 10.2.16 Item 16 - DOD ACTIVITY ADDRESS CODE (CC 72-77). Assigned 6-position Department of Defense Activity Address Code (DODAAC) specified in the contract which authorizes the contractor to receive or ship Government property.
