3.2 The Report shall contain Demand Only Transactions of purchase of non-NSN material (DI BHJ) and shall identify non-stock numbered items that were fulfilled through local purchase or manufacture actions.

3.3 The report shall contain a summary of the data collected for DI DHA and DI BHJ Demand Only Transactions specified in NAVSUP- P- 485, Volume I and shall include the following:

- a. Total number of MILSTRAP DI DHA transactions for the period of the report
- b. Total number of MILSTRAP DI BHJ transactions for the period of the report
- c. Summary of any MILSTRAP submission issues
- d. Microsoft (MS) Office Excel spreadsheet a listing of the data fields required per NAVSUP-P-485 03057 for each transaction (individual data fields will be the columns, each DI DHA/BHJ transaction will be a row) submitted during the reporting period shall be an attachment to the report
- e. Graphs reflecting the total DI DHA and DI BHJ transactions for the reporting period and the previous two reporting periods

3.4 Media Requirement. The Demand Only Transaction Report shall be presented in MS Office Suite, Word version 2003-2010.
