10. PREPARATION INSTRUCTIONS 10.2 <u>Source document</u> . The applicable issue of the document cited herein, including its approval date and dates of any applicable amendments and revisions, shall be as reflected in the contract. 10.2 <u>Format and content</u> . The format and content of the Data Management Plan shall be in accordance with the provisions of paragraph 4.1 of DOD-STD-1700(NS) as applied in the contract, in accordance with the preparation instructions below. 10.3 The plan shall describe the contractor's overall implementation of the Data Management requirements of DOD-STD-1700(NS) specified in the contract. 10.4 The following shall be addressed within the Data Management Plan: a. The plan shall define the scope and depth of the Contractor's efforts including management, organization, planning, and the relationship of the Data Management program to the contractor's other administrative and technical organizations. b. The plan shall specify what the contractor's management policies are and identify, by specific reference, standard practices and detailed work instructions to be used in implementing the Data Management program.
