10.2.2 Schedule. The schedule covers both work to be performed and material to be delivered. The first section shall list all indoor locations; the second section shall list all outdoor locations. Indoor locations shall be identified by building number. Outdoor locations shall be identified as a distance and direction from the nearest building(s) or other easily identifiable permanent structure or landmark. If base layout maps are used, outdoor locations shall be identified by the map grid number. Each section shall list start and completion dates, and description of work to be performed or material to be delivered in chronological order. Each page of the schedule shall include the covered schedule period. Each section shall also identify alternate work areas, in the event primary work areas are unavailable.
