All data shall be clearly presented and of readable size on standard 8 1/2 x 11 inch bond paper. 10.3 <u>General.</u> The Quality Inspection Test, Demonstration, and Evaluation Report shall be complete, accurate, and readable and shall provide sufficient data to determine that the hardware item meets all the requirements delineated in the contract. 10.3.1 <u>Content.</u> The Quality Inspection Test, Demonstration, and Evaluation Report shall consist of the following: a. Tracking the approved test plan and specified procedures in all categories. b. Citing detailed qualitative and quantitative data results such as test categories, test conditions, test methods employed, and types of inspection and test equipment used during the test or inspection.
