PREPARATION INSTRUCTIONS 10.1 <u>Specific instructions.</u> The demilitarization and disposal plan shall provide the following data in the format shown:  10.1.1 <u>Purpose.</u> This section shall state that the purpose of the plan is to identify safe and environmentally acceptable demilitarization and disposal requirements for . . . .  10.1.2 <u>Item description.</u> This section shall describe the configuration of the item with attached illustration(s). List the composition, weight, and quantity for each component, as well as the aggregate weight of all materials in the item. List all classified items and components and provide minimum declassification requirements for each. List all precious metals and materials and identify quantity of each.  10.1.3 <u>Safety summary.</u> This section shall summarize safety hazards that are unique to the item and precautions and procedures that must be employed during the demilitarization and disposal operation. List all hazardous materials in the item, e.g., tritonal, teteryl, carcinogenics, heavy metals, etc., and quantity of each.  10.1.4 <u>Environmental significance.</u> This section shall include an analysis describing the environmental significance of each demilitarization and disposal alternative.  10.1.5 <u>Demilitarization and disposal alternatives.</u> This section shall list alternative methods of demilitarization and disposal of the item(s) addressed by the plan identifying the preferred method. 10.1.8 Reference documents. This section shall list and identify directives and technical data specifically applicable to the plan.
