- 4.4.2.1: Add "11825936" and "Footnote 1/" to the next higher assembly.

Add Footnote 1 to read: "1/ Projectile, 30mm, TP, M788 (either Dwg. 9399640 or 11825948) may be used as an alternative to projectile, dummy, M848 (Dwg. 11825936) when the threaded bolt hole called out on Dwg. 11825957 (projectile, body, dummy) is added to it. These two alternates will undergo the same inspection process as the projectile, dummy, M848 (Dwg. 11825936).".

- * 4.4.2.1: Change Footnote 1/ to read: " 1/ Projectile, 30mm, TP, M788 (Dwg. 9399640) may be used as an alternative to projectile, dummy, M848 (Dwg. 11825936) when the threaded bolt hole called out on Dwg. 11825957 (projectile, body, dummy) is added to it. This alternate will undergo the same inspection process as the projectile, dummy, M848 (Dwg. 11825936).".

PAGE 9

Delete Section 5 in its entirety and substitute the following:

"5. PACKAGING

5.1 Packing level A. The type of ammunition pack shall be in accordance with instruction from the procuring activity. Ammunition shall be packed in accordance with Dwgs. 11825933, 11825934 or 12902726 as specified by the procuring activity.

5.2 Marking. Marking on the container shall be in accordance with drawing 11825893 or 12902718 as applicable.

5.3 Alignment of rounds in metallic strips. Cartridges shall be placed in the metallic strips in accordance with drawing 12910289.".

The margins of this amendment are marked with an asterisk or vertical line to indicate where changes (additions, modifications, corrections, deletions) from the previous amendment were made. This was done as a convenience only and the Government assumes no liability whatsoever for any inaccuracies in these notations. Bidders and contractors are cautioned to evaluate the requirements of this document based on the entire content irrespective of the marginal notations and relationship to the last previous amendment.
