

## INTERIM AMENDMENT

TO

## FEDERAL SPECIFICATION

## WATCH, WRIST

This interim amendment was developed by the Standardization Division, the General Services Administration, Federal Supply Service, Washington, D. C. 20406, based upon currently available technical information. It is recommended that Federal agencies use it in procurement and forward recommendations for changes to the preparing activity at the address shown above.

The General Services Administration has authorized the use of this interim amendment as a valid exception to Federal Specification GG-W-113A, dated June 6, 1967.

PAGE 1

Paragraph 2.1 Under subparagraph heading "Federal Specifications", add:

PPP-B-566 Boxes, Folding, Paperboard.  
 PPP-B-636 Box, Fiberboard.  
 PPP-B-676 Boxes, Set-up Paperboard.

PAGE 2

Paragraph 2.2 Add the following publications:

Nongovernmental:National Motor Freight Traffic Association, Incorporated, Agent:

National Motor Freight Classification.

Paragraph 3.3.1 After "Tritium" delete "hydrogen 3" and add "(H<sup>3</sup>) or ceramic encapsulated promethium (PM<sup>H<sup>3</sup></sup>)".

Paragraph 3.5 After "The dial" delete "shall be of nonferrous metal and".

Paragraph 3.7.1 After "fabricated" delete "in accordance with" and add "in such a manner as to be similar in design to."

Paragraph 3.7.2 After "fabricated" delete "in accordance with Drawing B8289351." and add: "in such a manner as to be similar in design to Drawing B8289351 and shall properly fit the case."

PAGE 4

Paragraph 4.2 Delete in its entirety and substitute:

4.2 Qualification test samples. Ten watches shall be submitted for qualification testing in compliance with 3.1 After obtaining authorization for submittal from the activity responsible for qualification, each watch submitted (see 6.6), shall be identified by a securely attached durable tag marked with the following information:

Sample for Qualification Tests.

Submitted by (name) (date) for qualification tests in accordance with the requirements of GG-W-113 under authorization (reference letter authorizing test).  
Manufacturer's model, grade, or part number.  
Name of manufacture.

Paragraph 4.2.1, line 2. Delete "6.7" and insert "6.6".

Table I, on line with "Major: AQL 2.5 percent" delete "3.4.1" and "4.7.6".

PAGE 8

Paragraph 5.1 and 5.2 Delete in its entirety and substitute:

5.1 Packaging. Packaging shall be level A, B, or C, as specified (6.1).

5.1.1 Level A. The packaging shall be in accordance with group 1, level A in PPP-T-360.

5.1.2 Level B.

5.1.2.1 Unit packaging. Each wrist watch shall be wrapped in neutral tissue paper. The wrist strap shall be wrapped around the watch and cushioned to prevent damage to the instrument. Each watch, wrapped and cushioned shall be packaged in a paperboard box conforming to PPP-B-676 or PPP-B-566. The box shall be closed as specified in the appendix to the applicable box specification.

5.1.2.2 Intermediate packaging. Ten unit packages of wrist watches shall be intermediate packaged in a fiberboard box conforming to PPP-B-636, class domestic.

5.1.3 Level C. Wrist watches shall be packaged to afford adequate protection against damage during shipment from the supply source to the first receiving activity.

5.2 Packing. Packing shall be level A, B, or C, as specified (6.1).

5.2.1 Level A. The packing shall be in accordance with group 1, Level A of PPP-T-360.

5.2.2 Level B. Six intermediate packages (60 watches) shall be packed in a close-fitting fiberboard box conforming to PPP-B-636, class domestic. Closure of the fiberboard box shall be in accordance with the appendix of PPP-B-636.

## PAGE 8 (CONT'D)

5.2.3 Level C. Wrist watches in quantities as specified (6.1), packaged as specified in 5.1.3, shall be packed in containers to assure carrier acceptance and safe arrival at destination in compliance with Uniform Freight Classification Rules or National Motor Freight Classification Rules.

5.8 Marking. In addition to the marking requirements specified in PFP-T-360, the unit package, intermediate package, and shipping container shall be marked with the date of acceptance by the Government.

Paragraph 6.1 Add the following new subparagraph:

(f) Quantities required in level C packing (5.2.3).

Paragraph 6.2 After "Tritium" add "or Promethium".

Paragraph 6.3 Delete in its entirety.
