FEDERAL SPECIFICATION

CABLE, TELEPHONE (W-108-B)

This amendment, which forms a part of Federal Specification J-C-96A, dated March 8, 1971, was approved by the Commissioner, Federal Supply Service, General Services Administration, for the use of all Federal agencies.

2.1 Under "Federal Specifications", delete "PPP-B-585" in its entirety, and insert in its proper sequence "PPP-F-320 - Fiberboard, Corrugated and Solid, Sheet Stock (Container Grade), and Cut Shapes."

2.1 Under "Military Specifications", insert in its proper numerical sequence "MIL-C-12000- Cable, Cord and Wire, Electric; Packaging of."

PAGE 3

2.2 Under "Other publications", delete "National Motor Freight Traffic Association, Inc., Agent" and "Uniform Classification Committee, Agent" in their entirety.

PAGE 14

5.2.1 Level A, Delete in its entirety and substitute:

5.2.1 Level A. Four coils of cable, each coil 1,000 feet in length unless otherwise specified, shall be packed in accordance with the level A coil packing requirements for MIL-C-12000.

PAGE 15

5.2.2 Level B. Delete first sentence and substitute "Unless otherwise specified, the following shall apply: The cable shall be uniformly coiled and packed in 1,000 feet lengths."

5.2.2.1, delete in its entirety.

5.2.3 Level C. Delete in its entirety and substitute:

5.2.3 Level C. The cable shall be packed in accordance with the level C packing requirements of MIL-C-12000. When fiberboard is utilized, it shall conform to PPP-F-320.

(b) Level of packing required for shipment (levels A, B, and C).
