UNDERSHIRT, MAN'S, (QUARTER-SLEEVE)

This amendment which forms a part of Federal Specification JJ-U-513D, dated September 11, 1975, was approved by the Commissioner, Federal Supply Service, General Services Administration, for the use of all Federal agencies.

3.2, after title: Add "(see 6.7)".

PAGE 7

Operation 3 a, under "Thread Bobbin or Looper": Delete "70-4" and substitute "70-3".

After operation 3 b: Add

"- or -

c. Non-continuous collarettes may be pre-seamed prior to joining to undershirt by stitching both ends together. The stitching shall be folded to the inside prior to attaching to the undershirt. The collarette seam shall be in line with a shoulder seam within 1/4 inch.

PAGE 17

Add following defect for Collarette:

"Preseamed non-continuous collarette out of line with shoulder seam by more than 1/4 inch."
Classify as Minor.

PAGE 18

Table VI, footnote 1/: Add "Oil splashes (clean, unused oil) on OG 109 undershirts up to 1/2 inch shall not be scored. Such splashes in excess of 1/2 inch shall be scored as a minor defect."

PAGE 24

Add the following new paragraph:

"6.7 Recycled material. It is encouraged that recycled material be used when practical as long as it meets the requirements of this specification (see 3.2)."

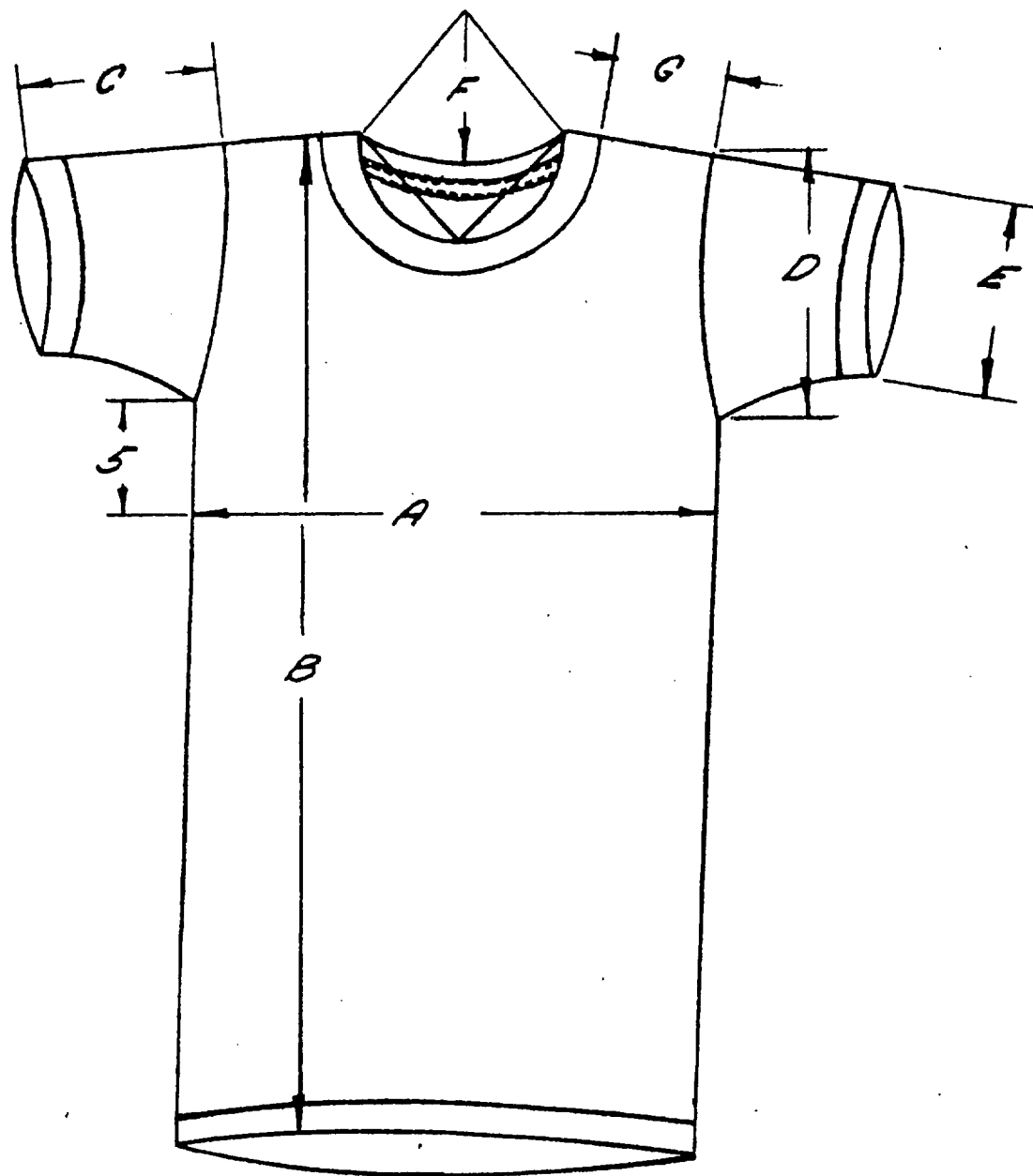
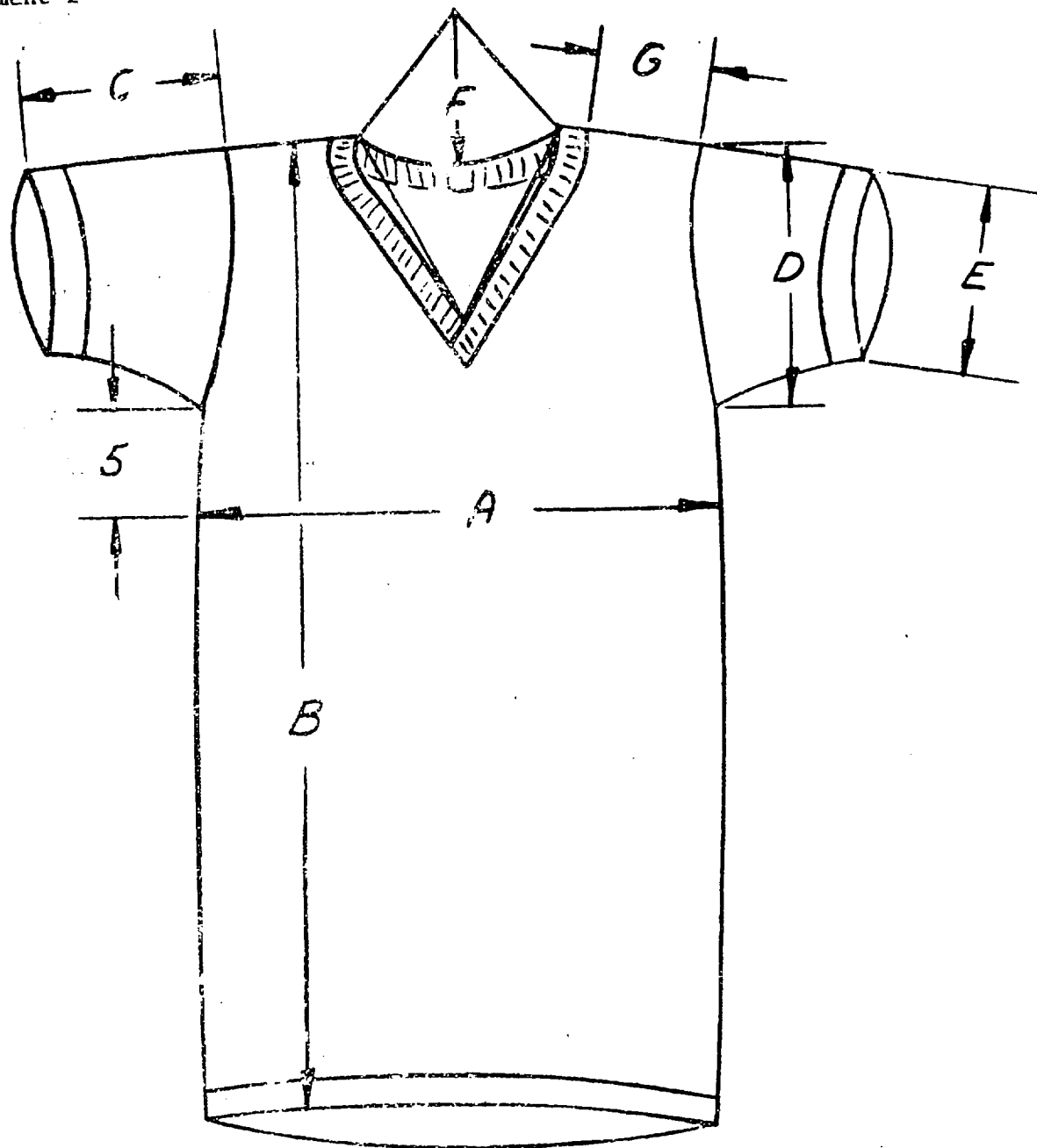


FIG. 1 UNDERSHIRT, MAN'S

Add Figures 1 and 2 as pages 25 and 26 respectively.
