"3.2.5.1 Color and treatment. Thread for the class 2 and 3 tarpaulins shall be natural color. Thread for the class 1 tarpaulins shall be dyed Olive Drab S-1 (C.A. 66022). Thread for the class 4 tarpaulins shall be dyed Desert Tan 459. Dyed thread shall show colorfastness to weathering equal to or better than the standard shade sample. When no standard shade sample is available the dyed thread shall show good colorfastness to weathering."
