FEDERAL SPECIFICATION

LEATHER, CATTLEHIDE, VEGETABLE TANNED AND
CHROME RETANNED, IMPREGNATED: AND SOLES

This amendment, which forms a part of Federal Specification KK-L-165C, dated May 1, 1969, was approved by the Commissioner, Federal Supply Service, General Services Administration, for the use of all Federal agencies.

PAGE 2

Add the following new paragraph:

"2.2 Other publications. The following documents form a part of this specification to the extent specified herein. Unless a specific issue is identified, the issue in effect on date of invitation for bids or request for proposal shall apply:

National Motor Freight Traffic Association, Inc., Agent

National Motor Freight Classification

3.1, after title. Add "The leather and the cut stock shall be full grain cattlehide consisting of steerhides or cowhides. Bullhides shall not be permitted."

3.2.2.1, after title. Add "A thickness tolerance of -0, +1 iron shall be permitted."

3.2.2.2, line 2. Delete "+1 iron" and substitute "+1 iron". At end of paragraph add "If the soles have been leveled, a thickness tolerance of -1/2, +1 iron shall be permitted."

3.2.3.1.2, line 1. After "backs" add ", bends".

3.2.3.3, line 1. After "backs" add ", bends".

PAGE 4

3.2.6 After column heading "Compressibility, percent, maximum" add "1". Under column add "1/ The compressibility of 1 inches, regardless of the type of leather, shall be no greater than 25 percent when tested as specified in 4.3."

Table I in Characteristic column. Delete "Degree of tannage". In columns for Type I and Type II. Delete "61.0".

PAGE 5

4.2.3, line 7. Delete "91" and substitute "51". At end of paragraph add: "Separate examinations shall be performed for visual and dimensional characteristics, but the same sample may be used for each examination."

PAGE 7

Table III, "Acceptable characteristics" column, line 4. Delete "or in" and substitute "or if in".

PAGE 8

Footnote "1/" to table III, line 3. Delete "strength" and substitute "stretch".

PAGE 9

Table IV. Delete "Degree of tannage" and testing requirements in all columns opposite this characteristic.

PAGE 11

4.4.4, line 3. Delete " W_2 " and substitute " W_3 ".

PAGE 12

5.2.2.3 Delete last sentence and substitute: "Containers shall be in accordance with Uniform Freight Classification or National Motor Freight Classification as applicable."

5.3, after title. Add "Marking shall be in accordance with 5.3.1 or 5.3.3 as specified (See 6.2)."

5.3.2 Delete in entirety.

PAGE 13

6.2 Add the following new subparagraph: "(h) Marking required (see 5.3)."

6.4, line 5. Delete "Class 5 Official" and substitute "Class 5 Offal".
