INTERIM AMENDMENT TO
FEDERAL SPECIFICATION

LINOLEUM; DESK TOP

This interim amendment was developed by the Naval Facilities Engineering Command (CBC, Davisville, R.I. 02854), based on currently available technical information. It is recommended that Federal agencies use it in procurement and forward recommendations for changes to the preparing activity at the address shown above.

The General Services Administration has authorized the use of this interim amendment as a valid exception to Federal Specification LLL-L-354c.

2.1 Under Federal Specifications delete "PPP-B-601" and "PPP-B-636" and substitute:

- "UU-P-268 - Paper, Kraft, Untreated, Wrapping.
- MMM-A-260 - Adhesive, Water-Resistant (For Sealing Waterproofed Paper).
- PPP-B-601 - Boxes, Wood, Cleated-Plywood.
- PPP-B-640 - Box, Fiberboard, Corrugated, Triple-Wall.
- PPP-B-1055 - Barrier Material, Waterproofed, Flexible."

Section 5. Delete and substitute:

"5. PREPARATION FOR DELIVERY

5.1 Packaging. Packaging shall be level A, B, or C, as specified (see 6.2).

5.1.1 Level A. Rolls of desk top linoleum in width and length as specified (see 6.2) shall be individually wrapped in waterproofed kraft paper conforming to PPP-B-1055, with all folds, seams and laps of the wrap sealed with water-resistant adhesive conforming to MMM-A-260.

5.1.2 Level B. Rolls of desk top linoleum, in the width and length as specified (see 6.2), shall be individually wrapped in paper conforming to UU-P-268, grade B, with all folds, seams, and laps secured with tape.

5.1.3 Level C. Rolls of desk top linoleum shall be packaged in accordance with the supplier's standard practice.

5.2 Packing. Packing shall be level A, B, or C as specified (see 6.2).

5.2.1 Level A. The desk top linoleum, packaged as specified in 5.1, in quantities as specified (see 6.2), shall be packed in boxes conforming to PPP-B-640 (class 2, grade a) or PPP-B-601, overseas type. The boxes shall be closed, and strapped in accordance with the applicable box specification appendix, except that flat steel strapping shall be type 1, class 1. Cleated wood boxes exceeding 250 pounds gross weight shall be modified by the addition of skids in accordance with PPP-B-601.

5.2.2 Level B. The desk top linoleum, packaged as specified in 5.1, in the quantities as specified (see 6.2) shall be packed in boxes conforming to PPP-B-640, class 1, or PPP-B-601, domestic type and shall be strapped in accordance with the appendix thereto.

5.2.3 Level C. The desk top linoleum in quantities, as specified (see 6.2), packaged as specified in 5.1 shall be packed in containers to assure carrier acceptance and safe arrival at destination in compliance with the Uniform Freight Classification Rules or the National Motor Freight Classification Rules.

5.3 Marking, (see 6.2).

5.3.1 Civil agencies. In addition to any special marking required by the contract or order, packages and shipping containers shall be marked in accordance with Fed. Std. No. 123.

5.3.2 Military agencies. In addition to any special marking required by the contract or order, packages and shipping containers shall be marked in accordance with MIL-STD-129."

6.2 (g). Delete and substitute:

"(g) Quantities of desk top linoleum to be furnished in the shipping container (see 5.2).

(h) Marking required (see 5.3)."
