2.2, under "American Society for Testing and Materials (ASTM)": Delete lines 1 and 2 and substitute "A 167 - Stainless and Heat-Resisting Chromium-Nickel Steel Plate, Sheet and Strip" and "A 176 - Stainless and Heat-Resisting Chromium Steel Plate, Sheet and Strip."

2.2, line 6: Delete "ICS-1970" and substitute "ICS"

3.3.3, line 2: Delete "-1970"

PAGE 5

3.5.1, line 3: Delete "A167-70" and A176-71" and substitute "A 167" and "A 176" respectively.

PAGE 6

3.5.5: Delete in its entirety and substitute "3.5.5 Motors. Motors shall conform to the requirements of CC-M-1807 and the following."

3.7.2.6, 2nd sentence: Delete and substitute "The press shall be equipped with a built in yoke or a yoke pressing attachment."
