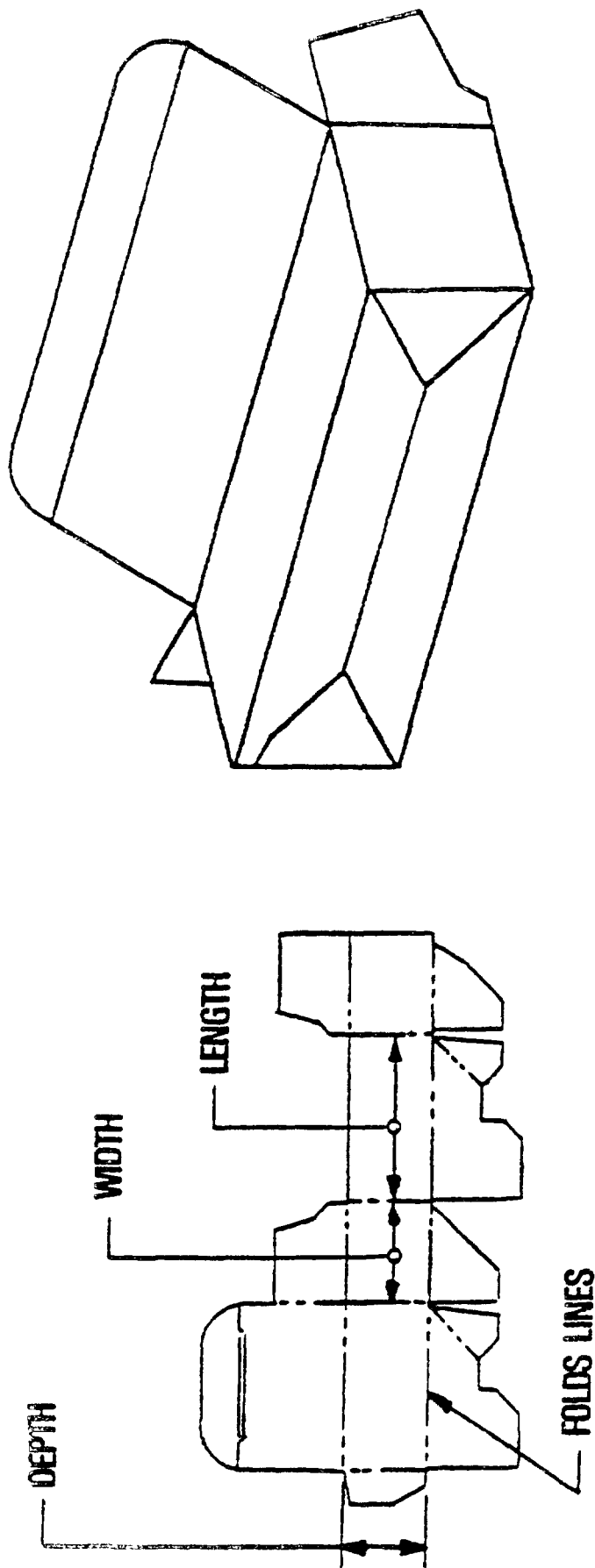


DIAGRAM SHOWING THE
