Fiberboard used in the construction of class 3 boxes shall meet the fire retardant requirements of PPP-F-320."

- 3.1.3.2, line 1, after "class 2": Add "and class 4".

4.6.6, line 1, after "class 2": Add "add class 4".

- 6. NOTES Add the following:
- "6.1.3 Class 3 use. Boxes are for shipments and storage involving extreme climatic conditions but where fire retardant fiberboard is desired. Fire retardant fiberboard is intended to reduce the risks and hazards of fire aboard Navy ships and to improve fleet readiness losses due to fire destruction in compliance with the Navy Passive Fire Protection Program."

"6.1.4 <u>Class 4 use.</u> Boxes are for shipments and storage involving extreme climatic conditions and when exposure to high humidities is contemplated. Fire retardant fiberboard is intended to reduce the risks and hazards of fire aboard Navy ships and to improve fleet readiness by reducing losses due to fire destruction in compliance with the Navy Passive Fire Protection Program."
