- "3.1.2 Type I, classes d, e, and f. Material supplied to type I, classes d, e, and f, may be in accordance with ASTM A 527, A 528, or A 642 with general requirements in accordance with ASTM λ 525."
 - 3.3, after "Decimal thickness", add "(minimum or nominal)".

- "4.1 Responsibility for inspection. Unless otherwise specified in the contract, the contractor is responsible for the performance of all inspection requirements as specified herein. Except as otherwise specified in the contract, the contractor may use his own or any other facilities suitable for the performance of the inspection requirements specified herein, unless disapproved by the Government. The Government reserves the right to perform any of the inspections set forth in the specification where such inspections are deemed necessary to assure supplies and services conform to prescribed requirements."

6.1, line 7: Delete "ASTM A 628", and substitute "ASTM A 642".

Add new subparagraph 6.1.1:

"6.1.1 The weight or class of coating specified should be compatible with the desired service life, thickness of the base metal, and with the forming requirements involved as specified in 3.1.1 and 3.1.2. Under atmospheric conditions, the protection afforded by the coating is directly proportional to the weight of coating. The coating is expressed as the total coating on both surfaces in ounces per square foot (oz/ft²)."

6.2(b): Delete "(see 1.2.1)" and substitute "(see 1.2.1, 3.1.1, and 3.1.2)."
