4. GENERAL STATEMENTS

4.1 This handbook may be used by the military services in preparing military specifications and is intended to standardize clothing components for use in the development of items of military uniforms.

4.2 Unless otherwise specified, all stitches, seams and stitchings shall be in accordance with FED-STD-751.

5. DETAIL REQUIREMENTS

5.1 Ornamentation. Ornamentation for military uniforms should conform to the following specifications (as applicable):

5.4 Tab, collar or tie. Collar tabs or tie tabs for women's shirts may be fabricated from polyester/cotton, durable press cloth conforming to MIL-C-43843.

5.5 Suspender loops. Nylon laces for suspender loops or similar constructions should conform to:

5.7.2 Buttons, metal. Metal insignia buttons for military uniforms should conform to:

5.8 Fasteners.

5.8.1 Fasteners, hook and eye (trouser). Nickle plated hook and eye fasteners for closing trouser waistbands should be North and Judd (Hook Flex H-49, K-50, H-89 and E-90); Universal Button Co. (Talon #3, #7, and #8 hook with #8 eye or #85 eye); Axim Co. Junior Series, type JB; Stimpson (P-536, D-4086, D-4457, D-4288; RAU (OA50, OX1256, 0804415), Patwin Inc. (Slim-Slak with MB eye, and Slik Slak); or equal.

5.8.2 Fasteners, collar closure hook and eye. Hooks and eyes for collar closures should be brass commercial type or as specified.

5.8.3 Fasteners, slide. Slide fasteners for military uniforms should conform to:

- V-F-106 - Fasteners, Slide, Interlocking

5.8.4 Fasteners, snap (clinch-on type). Clinch-on type snap fasteners for military uniforms should conform to:

- MIL-F-10884 - Fasteners, Snap

5.8.5 Fasteners, snap (sew-on type). Sew-on type snap fasteners should be brass, rolled edge, round or square type.

5.8.6 Fastener tapes. Hook and pile fastener tapes for military uniforms should conform to:

- MIL-F-21840 - Fastener Tapes, Hook and Pile, Synthetic

5.9 Tape. Tapes for binding seams or edges, reinforcements, bridles, stays, hem finishing, and other uses should conform to the following specifications (as applicable):

- DDD-B-1199 - Binding Textile, Cotton, Bias Cut

- DDD-T-86 - Tape, Textile; Cotton, General Purpose
(Unbleached, Bleached, or Dyed)

5.12 Interlining. Interlinings for military uniforms should conform to the following specifications (as applicable):
