2.2.2: Delete.

3.1, line 3: Delete “at the time set for opening of bids” and substitute “prior to the award of a contract”.

3.2.2: Delete.

3.4: Delete first and second sentences and substitute “The coating furnished under this specification shall be in the form of a kit consisting of component A, a pigmented epoxy resin, and component B, a clear curing agent”.

3.4.1: Delete.

4.3.1: Delete first sentence. After the first word “For” in the second sentence add the following “routine and”.

4.3.2: Delete first sentence and substitute “The test procedures shall include the tests and test methods specified in table II”.

TABLE II, fourth row: Delete row called “pigment analysis”.

4.3.3, line 2: Delete superscript “1”. After the word “thick” insert “(see 6.3.1)”.

4.3.4, line 3: Delete superscript “2”. After the word “hiding” insert “(see 6.3.1)”.

Footnotes 1 and 2, bottom of page: Delete.

4.3.10.1, line 5: Delete superscript “3”. After the word “shaker” insert the following “powered by a 1/4 horsepower motor, that operates at an approximate rate of 1350 shakes per minute”.

Footnote 3, bottom of page: Delete.

6.3, line 4: Delete “2331” and substitute “231”.

Add as new paragraph:

“6.3.1 Panels and charts. S-36 or equivalent test panels available from the Q Panel Company in Cleveland, Ohio are acceptable for use in 4.3.3. Form 2A or equivalent black and white hiding charts available from the Leneta Company in Ho-Ho-Kus, New Jersey are acceptable for use in 4.3.4.”

6.4, line 2: Delete “at the time set for opening of bids” and substitute “prior to the award of a contract”.
