PAINT COATING SYSTEMS, FUEL AND

This amendment forms a part of MIL-P-23236B(SH), dated 11 August 1988, and is approved for use by the Naval Sea Systems Command, Department of the Navy and is available for use by all Departments and Agencies of the Department of Defense.

PAGE 1

- * 1.2, line 7: Delete type IV in its entirety and substitute: "Type IV - A coating system with a maximum solvent content of 340 grams per liter of paint (2.8 pounds of solvent per gallon of paint)."
- * 1.2, Add at end:

"Grade B - A coating system which is to be stored, applied and cured at a temperature range of 11 to 38 degrees Celsius (°C) (51 to 100 degrees Fahrenheit (°F))."

PAGE 4

- * 3.2.1.1, line 2: Delete "either 340 or 290" and substitute "a maximum of 340".

PAGE 6

3.12.1: Add as new paragraph:

- * "3.12.1 Polychlorinated biphenyls (PCB). Polychlorinated biphenyls (PCB) shall not be used in coating systems covered by this specification."

- * 5.2.1, line 2: After "type III" add "or type IV".
- * 5.2.1, after line 3: As a new subhead, add "Type III".
- * 5.2.1, after line 7: Add

"Type IV

"The volatile content of the material conforms to the requirements of Rule 1106 of the South Coast Air Quality Management District. This paint may be used where air pollution regulations apply. This includes other air pollution control districts or similar areas controlling the emission of solvents into the atmosphere. (See 6.3.)"

- 6.2.2, line 12: Delete "UDI-A-23264" and substitute "DI-MISC-80678".

PAGE 20

- * 6.3, line 1: After "type III" add "and type IV" and delete the "s" in "refers".
- * 6.3, line 3: After "3.2.1" add "or 3.2.1.1".
- * 6.3, line 5: Delete the comma after "102" and add "and Rule 1106".

PAGE 23

- 10.1, line 4: Delete "UDI-A-23264" and substitute "DI-MISC-80678".
