

#### 1. SCOPE

1.1 <u>Scope</u>. This specification covers the performance requirements for style RBR57, nonestablished reliability, established reliability, accurate, wire-wound, fixed resistors.

1.2 <u>Part or Identifying Number (PIN)</u>. Resistors covered by this specification are identified by a PIN which consists of the style designation, terminal, resistance, resistance tolerance, and product level designator. The PIN is derived in accordance with MIL-PRF-39005 and is in the following form:

## 3. REQUIREMENTS

3.1 <u>General</u>. The requirements for acquiring the product described herein shall consist of this document and MIL-PRF-39005.

3.2 <u>Interface and physical dimensions</u>. Resistors shall meet the interface and physical dimensions specified on figure 1.

3.3 <u>Minimum resistance value and applicable tolerance</u>. Minimum resistance value shall be 0.1 ohm for tolerance F ( $\pm$ 1.0 percent). For tolerances B, A, Q, T ( $\pm$ .10,  $\pm$ .05,  $\pm$ .02, and  $\pm$ .01 percent, respectively), the minimum resistance value shall be 10 ohms.

3.4 <u>Maximum resistance value</u>. Maximum resistance values and applicable wire sizes shall be as follows:

3.5 <u>Power rating</u>. Power rating shall be 0.75 watt.

3.6 <u>Maximum voltage</u>. Maximum voltage shall be 600 volts direct current or peak.

3.7 <u>Maximum weight</u>. The maximum weight shall be 10 grams.


## 4. VERIFICATION
