This amendment forms a part of Military Specification MIL-A-22641C, dated 27 July 1972, and is approved for use by all Departments and Agencies of the Department of Defense.

PAGE 2

- * 2.1, list of Military Specifications, delete "MIL-A-22641/16", "MIL-A-22641/17", "MIL-A-22641/18", "MIL-A-22641/19", and "MIL-A-22641/20", with corresponding titles, and substitute:

"See supplement 1 for list of associated specification sheets."

- * 2.1, list of Military Specifications, add:

"MIL-W-85 - Waveguides, Rigid, Rectangular, General Specification for.
 MIL-W-23351 - Waveguides, Single Ridge and Double Ridge, General Specification for.
 MIL-F-39000 - Flanges, Waveguide, Ridge, General Specification for."

PAGE 3

- * 3.4.5, delete and substitute:

"3.4.5 Waveguide flange. The waveguide flange used with each adapter shall properly mate with the flange specified (see 3.1), which shall conform to MIL-F-3922 or MIL-F-39000."

- * 3.4.6, delete and substitute:

"3.4.6 Waveguide. The waveguide used with each adapter shall be as specified (see 3.1), and shall conform to MIL-W-85 or MIL-W-23351."

- 3.4.10, delete and substitute:

"3.4.10 Finish. All exterior surfaces of the adapter, except mating surface, shall be finished in accordance with finish number P511, type I of MIL-F-14072 for aluminum alloy adapters, and finish number P213, type I of MIL-F-14072 for copper alloy adapters, with final film E of MIL-F-14072 conforming to type III, class 2 of MIL-E-15090."

PAGES 6 AND 7

- 4.5.2 through 4.5.2.3 and tables III and IV: Delete in their entirety.
