A numerical equivalent to the dash number indicating size is optional. All fittings and nuts larger than 3/8 inch tube size shall be marked with the part number exclusive of size."

6.1, third line, delete "pages" and substitute "gages."

6.3, last sentence, delete and substitute "The activity responsible for the Qualified Products List is the Engineering Division, San Antonio ALC/MMEDO, Kelly AFB, Texas 78241, and information pertaining to qualification of products may be obtained from that activity."
