3.6: Delete first sentence and substitute:

"When process 2 is specified (see 6.2), the entire crate shall be completely immersed or flushed for a minimum of 3 minutes in a preservative conforming to composition B, C, or D of TT-W-572. The preservative treated crates shall not discolor the dye when tested in accordance with 4.4.3."

Last line: Add "For OCONUS shipment, process 2 or 3 must be used (see 6.2)."

6.2: Add "(i) Whether process 2 or 3 preservative treatment is required for OCONUS shipments.
