"3.2 First article inspection When specified (see 6.2), before production is commenced, 1 yard of the desized, mercerized dyed cloth and 5 continuous yards full width of the finished (fire retardant) cloth shall be submitted or made ready for the contracting officer or his authorized representative for inspection. The (fire retardant) treatment used for the finished cloth shall be identified in sufficient detail for recognition as an approved type. The first article sample shall be manufactured by the supplier in the same facilities to be used for the manufacture of the production items. The approval of the first article samples authorized the commencement of production but does not relieve the supplier of responsibility for compliance with all applicable provisions of this specification."

Except as otherwise specified in the contract or purchase order, the contractor may use their own or any other facilities suitable for the performance of the inspection requirements specified herein, unless disapproved by the Government. The Government reserves the right to perform any of the inspections set forth in the specification where such inspections are deemed necessary to assure supplies and services conform to prescribed requirements
- \* "4.1.1 Responsibility for compliance. All items shall meet all requirements of sections 3 and 5. The inspection set forth in this specification shall become a part of the contractor's overall inspection system or quality program. The absence of any inspection requirements in the specification shall not relieve the contractor of the responsibility of ensuring that all products or supplies submitted to the Government for acceptance comply with all requirements of the contract. Sampling in quality conformance does not authorize submission of known defective material, either indicated or actual, nor does it commit the Government to acceptance of defective material "
