2.1.1, line 14: Delete "Wood and Nylon, Shrink Resistant" and substitute "Wool and Nylon, 16 Ounce, Shrink Resistant".

2.2, line 8, add the following:

3.2.1.1, line 8: Delete "If printed seconds are used, they must be marked on the face side with stripes 3 inches apart the length of the roll. The color of the stripes shall approximate any of the four camouflage print colors. Colorfastness to crocking shall be no lower than 6.5 (Munsell scale)".

3.2.3, line 13, opposite "Tearing strength (grams, min.)": Delete "1770" and "2040" and substitute "1600" and "1840" respectively.

Table II, operation 6, line 4: Delete "evenly matched" and substitute "matched plus or minus 1/16 inch".

Table II, operations 5a, 6c, 6e, 7a, 7b, and 7c in columns for "Stitch type" "Stitches per inch", "Needle" and "Bobbin/Looper" add: "and 301", "10-14", "50 or 30" and "50 or 30".

Table II, operations 6d, 9c, 9d, and 11a in columns for "Needle" and "Bobbin/Looper" add: "or 30" to each column.

Table II, operation 9.c, under "Stitches per inch": Delete "50" and substitute "10 - 14". Under "Thread - Bobbin/Looper": Add "50".

Table II, operation 10b, in column for "Bobbin/Looper" add: "or 30".

Table II, operation 10c, in columns for "Needle" and "Bobbin/Looper": Add "or 50".

Add the following new paragraph:

"4.2.1.2 Certification. When printed or dyed seconds are used, the contractor shall furnish a certificate of compliance indicating that they meet the requirements in 3.2.1.1."
