Section 5 - Delete in its entirety and substitute the following:

"5. PACKAGING

5.1 <u>Pilot pack</u>. - A pilot pack shall consist of a complete clip preserved in accordance with Packaging Data Sheet Pl1010483 for the level of protection specified in the contract (See 6.1), packed level B and forwarded as specified in 3.1.

5.2 <u>Levels A and B</u>. - Preservation, packing and marking shall be in accordance with Packaging Data Sheet Pll010483 for the level of protection specified in the contract (See 6.1).

5.3 <u>Commerical packaging</u>. - Preservation, packing and marking shall be in accordance with MIL-STD-1188 except that the quantities per unit pack shall be as specified in the contract (See 6.1).

Paragraph 6.1.1 - Delete procurement requirement "g" and substitute the following:

"g. Selection of applicable level of protection (A or B), or commercial packaging (See 5.1, 5.2 and 5.3)."

Add procurement requirement "h" as follows:

"h. Quantities per unit pack for commercial packaging (See 5.3)."
