MILITARY SPECIFICATION

CARTRIDGE, 7.62MM, NATO, BALL, FRANGIBLE, M160

This Amendment forms a part of Military Specification MIL-C-46932A (MU) dated 24 August 1966, and is approved for use by the US Army Armament, Munitions and Chemical Command and is available for use by all Departments and Agencies of the Department of Defense.

Delete "AMCR 715-505 Volume 3" wherever it appears in the specification and substitute "SCATP-7.62."

\* 3.4 Delete "53 feet and 1320 feet" and substitute "78 feet and 1300 feet" respectively.

3.8 - Add the phrase "when conditioned for not less than 2 hours at 68°F to 72°F (room temperature)" to the end of the paragraph.

4.3.2.1 - Table I, Defect No. 47: Change classification of defect from "Major X" to "Critical X"

4.3.2.1 - Delete footnote 2 to Table I and substitute the following:

"2/ Each light or heavy weight cartridge shall be disassembled and the propellant weighed. Each such cartridge found to contain from 6 to 18 grains of propellant inclusive shall be counted as a major defect. Any cartridge containing less than 6 or more than 18 grains of propellant shall be classified as a critical defect."

4.3.3.1 - Table II: Delete "Ambient Temperature" from the heading.

\* Delete "M73" and substitute "M240".

4.3.3.2 - Table III: Change defect numbers from "3, 4, 5 and 6" to "4, 5, 6 and 7" respectively. Add new defect number 3 as follows:

"3. Hangfire 3/ 0 -"

Add footnote 3/ to Table III as follows:

"3/ For definition of hangfire, see SCATP-7.62 paragraph 10.6.2"

4.4.7 - Last sentence: Delete the phrase "average of the."

\* 4.4.6 Delete "M73" and substitute "M240".
