5. Packaging. Delete entirely and substitute:

" 5. PACKAGING

5.1 Preservation. Preservation shall be level C or Commercial (see 6.2).

5.1.1. Cleaning and Drying. Items shall be cleaned and dried using any suitable process specified in MIL-P-116.

5.2 Packing. Packing shall be level C, or Commercial as specified (see 6.2).

5.2.1. Assembly. Assemble drums with all components in place and with the locking rings snugly applied. The bolt and nuts shall be hand tightened until snug, then rotated one-quarter turn more. (see 4.5.4.1.)

5.2.2. Level C. Packing shall be applied which affords adequate protection during shipment.

5.2.3. Commercial. All drums packed to this level must conform to requirements in ASTM D3951.

5.3. Palletization. Palletization of drums or boxes shall be in accordance with MIL-STD-147 when specified (see 6.2).

5.4. Marking. In addition to any other markings required by the contract or order (see 6.2), interior and exterior containers shall be marked in accordance with MIL-STD-129. "
