When specified, provisions shall be made for the discharge of accumulated charges of static electricity by bringing the aircraft to ground potential on landing, and thus preventing shock to personnel and damage to the aircraft by controlling the point of discharge. The static grounding device shall be so installed as to be bonded to the aircraft structure and shall provide electric contact with the ground on landing. The device shall be adjustable or replaceable to compensate for normal wear, and shall not protrude from the aircraft during flight, except on landing and takeoff, if retractable landing gear is employed."
