Upon receipt of authorization (see 6.3) from the Commander, Attn: Code 4.3.4.1 Building 2188, Naval Air Warfare Center Aircraft Division, 22347 Cedar Point Road, Unit 5, Patuxent River MD 20670-1161 to submit samples for qualification testing, samples shall be forwarded as directed. The samples shall be accompanied by a test report from the manufacturer or a commercial laboratory containing complete information as to the source, the formulation and composition of the finished grease, and laboratory data showing quantitative results of all the tests required by this specification, except storage stability. A material safety data sheet shall accompany the samples being submitted for test. Samples shall be identified as follows:
 - Sample for qualification inspection
 - MIL-G-23549C, "GREASE, GENERAL PURPOSE"
 - Name of manufacturer
 - Product code number
 - Date of manufacture
 - Submitted by (name) and (date) for qualification inspection in accordance with the requirements of MIL-G-23549C under authorization of (reference authorizing letter) (see 6.3)."
