MILITARY SPECIFICATION

GLASS BEADS: FOR CLEANING AND PEENING

This amendment forms a part of Military Specification MIL-G-9954A dated 1 November 1966, and is approved for use by the Department of the Air Force and is available for use by all Departments and Agencies of the Department of Defense.

Page 1

Paragraph 2.1 - Under Specifications delete "Military, MIL-D-3464, Desiccants, Activated, Bagged, Packaging Use and Static Dehumidification".

Page 2

Paragraph 2.1 - Under Tech Manuals add "T.O. 1-1-2, Corrosion Prevention and Control for Aerospace Equipment".

Paragraph 2.1 - Under Technical Manuals delete "Air Force, TO 1-1-5, Abrasive Blasting Method of Cleaning and Corrosion Removal".

Paragraph 2.2 - Under American Society for Testing Materials Publications delete "C 169-69, Soda Lime Glass, Chemical Analysis of." and substitute "C169 Methods for Chemical Analysis of Soda-Lime and Borosilicate Glass."

Page 3

Paragraph 3.3 - After the word "Appearance" add "and Roundness". After the last sentence add the following sentence: "The roundness of the glass beads shall be specified in Table 1 for each size". (See 4.5.2)

* Paragraph 3.7 - Delete in its entirety, and substitute "Sieve analysis. The glass beads shall conform to the sieve analysis as specified in Table 1 when tested as specified. (See 4.5.6)"

Page 5

* Paragraph 4.3 - Delete the sentence "Each lot shall not exceed 2000 pounds" and substitute "Each lot shall not exceed 2000 pound consisting of 40 separate 50-pound containers."

Page 7

Paragraph 5.1.1 - Under sub-paragraph 1, delete "Type II and III, Grade X with dipped ends" and add "Type VI, Style B, MB-3, Sack No 13X, outer wall to be minimum of 50 LB basic weight".

Paragraph 5.1.1 - Sub-paragraph 4, delete in its entirety, and substitute the following: "When specified, five pounds of glass beads shall be placed in a plastic bag and the bag heat sealed. The vapor transmission-rate of the plastic bag shall be as specified in paragraph 5.1.4. Ten 5-pound bags shall be packed for shipment in a 50-pound container as specified in 1, 2, or 3 above."

Paragraph 5.1.2 - Under sub-paragraph 1, delete "Type II or III, Grade L/W" and add "Type VI, Style B, MB-3, Sack No 13X, Outer Wall to be minimum of 50LB Basic weight".

Paragraph 5.1.2 - Add a new sub-paragraph 4 as follows: "When specified, five pounds of glass beads shall be placed in a plastic bag and the bag heat sealed. The vapor transmission rate of the plastic bag shall be as specified in paragraph 5.1.4. Ten 5-pound bags shall be packed for shipment in a 50-pound container as specified in 1, 2, or 3 above".

Page 8

Paragraph 5.1.4 - In the first sentence, delete the words "with a minimum of eight units of desiccant conforming to MIL-D-3464".

Paragraph 6.1 - In the fourth line, insert "Air Force" between "with" and "Technical", delete "1-1-5" and substitute "1-1-2".

* Paragraph 6.3 - In Line 10, delete "Warner Robins Air Material Area (WRAMA), ATTN: MMIRDA" and substitute "WR-ALC/MMIRFW".
