

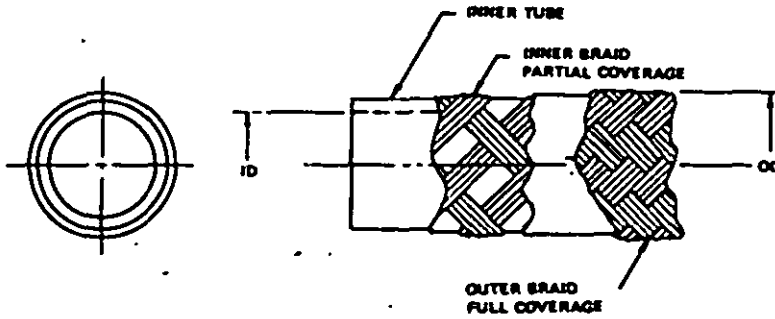

2. HOSE IS FOR USE WITH M83796/1 THROUGH M83796/9 FITTINGS IN M83796/1 THROUGH M83796/9 ASSEMBLIES.
