The Government reserves the right to perform any of the inspections set forth in the specification where such inspections are deemed necessary to assure supplies and services conform to prescribed requirements."

The preparation for delivery requirements of referenced documents listed in section 2 do not apply when material and parts are acquired by the contractor for incorporation into the equipment and lose their separate identity when the equipment is shipped."
 - 6.5: Delete and substitute:
- * "6.5 Sources of stock fungus cultures. The fungi designated for use in tests may be obtained from the American Type Culture Collection, 12301 Parklawn Drive, Rockville, MD 20852."
