2.2 Delete and substitute:

"2.2 Other publications. The following documents form a part of this specification to the extent specified herein. Unless otherwise indicated, the issue in effect on date of invitation for bids or request for proposal shall apply.

Table I, Class A: Under: "Silcon" and "Phosphorus" add footnote "3/" and add at end of table, "3/ For castings with sections 1/2 inch and smaller, maximum silicon content of 2.75 percent and maximum phosphorus content of .08 percent are allowed. For each reduction of .01 percent phosphorus below the .08 percent maximum specified, an increase of .08 percent silicon above the 2.75 percent maximum specified to a maximum of 3.00 percent will be permitted."

3.7, line 6: Delete "bureau" and substitute "command or".

* 4.1 Delete and substitute:

"4.1 Responsibility for inspection. Unless otherwise specified in the contract, the contractor is responsible for the performance of all inspection requirements as specified herein. Except, as otherwise specified in the contract, the contractor may use his own or any other facilities suitable for the performance of the inspection requirements specified herein, unless disapproved by the Government. The Government reserves the right to perform any of the inspections set forth in the specification where such inspections are deemed necessary to assure supplies and services conform to prescribed requirements.

4.1.1 Certification of quality compliance. A certificate of quality compliance shall be prepared for each lot of material offered for acceptance (see 6.1.1). The certificate shall include actual data of specified chemical and mechanical tests. Qualitative results of nondestructive tests and other inspections or tests shall be recorded on the certificate. The certificate shall also state that each lot has been sampled, tested, and inspected in accordance with the specification and meets all specification requirements. The certificate shall be signed by a responsible representative of the contractor."

4.3.1.1, line 2: Delete "bureau" and substitute "command".

4.3.1.3 Delete and substitute:

"4.3.1.3 Test specimens obtained from test blocks sectioned as shown on figure 2 shall be machined to the form of round type specimens as specified in ASTM E-8. In cases where castings are sectioned to obtain test specimens, the location from which test specimens are to be taken and the type of test specimen to be used shall be specified by the command or agency concerned."

4.3.1.4 Delete and substitute:

"4.3.1.4 One tension test shall be conducted for each lot in accordance with ASTM E-8."

4.3.2, line 7: Delete "bureau" and substitute "command".

"(The preparation for delivery requirements specified herein apply only for direct Government procurements.)"

* Add the following:

"6.1.1 Data requirements. When this specification is used in a procurement which incorporates a DD Form 1423 and invokes the provisions of 7-104.9(n) of the Defense Acquisition Regulations, the data requirements identified below will be developed as specified by the Data Item Description (DD Form 1664) and delivered in accordance with the approved Contract Data Requirements List (DD Form 1423) incorporated into the contract. When the provisions of DAR 7-104.9(n) are not invoked, the procurement document will specify that the data specified below is to be delivered by the contractor (use of the DID in this case is not required). Deliverable data required by this specification is cited in the following paragraph:

6.1.1.1 The data requirements of 6.1.1 and any task in section 3, 4, or 5 of this specification required to be performed to meet a data requirement may be waived by the contracting/acquisition activity upon certification by the offeror that identical data were submitted by the offeror and accepted by the Government under a previous contract for identical item acquired to this specification. This does not apply to specific data which may be required for each contract regardless of whether an identical item has been supplied previously (for example, test reports)."
