2. Page 3, paragraph 3.1: Replace with:

"3.1 <u>Construction</u>.- The mountings covered by this specification shall be constructed in accordance with the applicable drawings listed below:

3. Page 6, paragraph 3.12: Replace with:

"3.12 <u>Interchangeability.</u>— The contractor's procedures and methods—including engineering, production, and quality control—shall insure interchangeability of parts as specified below. However, when mutched parts are permitted by the Government, they need be interchangeable only as a pair or set.

3.12.1 <u>Corresponding parts.</u>- "Corresponding parts" as used herein, in connection with the interchangeability requirements, means all possible parts meeting a set of limiting values (dimensions, tolerances, ratings and limits). Such values shall be those specified in the applicable Government documents, supplemented as necessary with values established by the manufacturer of the part; however, if no Government document applies, the limiting values shall be those established by the manufacturer of the part. Amend 2 to Spec MIL-M-12575A(SigC)

3. Page 6, paragraph 3.12: (Contd)

3.12.2 Interchangeability requirement. - Any part shall be replaceable with any corresponding part without degrading electrical, mechanical or physical characteristics and performance below specified values and without modification of the replacement part or of any other item with which the replacement part is used. It is permissible, however, to use normal adjustments in meeting this requirement. (The foregoing requirement necessarily precludes reliance on selective assembly to meet specified requirements, or reliance on any characteristics not included in the limiting values of the part)."

4. Page 7, paragraph 4.1 and subparagraphs: Replace with:

"4.1 Inspection; responsibility and classification of.-

4.1.1 <u>Contractor's responsibility.</u>— The supplier is responsible for the performance of all inspection requirements as specified herein. Except as otherwise specified, the supplier may utilize his own or any other inspection facilities and services acceptable to the Government. Inspection records of the examination and tests shall be kept complete and available to the Government as specified in the contract. The Government reserves the right to perform any of the inspections set forth in the specification where such inspections are deemed necessary to assure that supplies and services conform to prescribed requirements.

4.1.2 Classification of Inspection. - Inspection shall be classified as follows:

(a) Preproduction inspection (does not include preparation for delivery). (See 4.2).

(b) Acceptance inspection.

(1) Acceptance inspection of equipment before preparation for delivery. (See 4.3).

(2) Acceptance inspection of preparation for delivery. (See 4.10 and section 5)."

5. Page 10, paragraph 4.3.3: Replace with:

"4.3.3 Group C Inspection.- This inspection shall be as listed in table V."

"4.10 Acceptance inspection of preparation for delivery.- Preparation for delivery shall be inspected in accordance with specification MIL-P-116 to determine conformance to the requirements of section 5."

5.1.2.2 Mounting MT-298()/GR: Items 8 through 13 of Figure 1 and Table VII except Items 9, 10, 11 and 13 shall be class 1, 200 PSI. The box closure shall be as specified except the tape shall conform to Specification UU-T-111, class 2. The piece of tape for the body joint shall be omitted.

5.1.2.5 Mounting MT-327()/GR: Items 30 through 33 of Figure 1 and Table X except Items 31 and 33 shall be class 1, 200 PS1. The box closure shall be as specified except the tape shall conform to Specification UU-T-111, class 2. The piece of tape for the body joint shall be omitted.

5.1.2.6 <u>Mounting MT-673()/GRs</u> Items 37 through 40 of Figure 1 and Table XI except Item 40 shall be class 1, 125 PSI. The box closure shall be as specified except the tape shall conform to Specification UU-T-111, class 2. The place of tape for the body joint shall be omitted.

5.1.3 <u>Package Performance</u>. – Package Testing shall be performed in accordance with the requirements of Specification MIL-P-116. The rough handling test and the cyclic exposure test will be required only when invoked in the bid request or contract (see 6.2).



 - (1) If rough handling test or cyclic exposure test is required."
- 12. Page 19, add paragraph:

"6.10 <u>Dimensional data.</u> Sizes of packaging materials prescribed in Section 5 are based on the dimensions of the equipment cited on the applicable Bill of Material. When the dimensions of the equipment vary from those cited, the sizes of the packaging materials shall be adjusted accordingly. When shown in the Bill of Materials (see Section 5), corrugated fiberboard manufactured with A, B or C fluting may be used at the option of the contractor. When the fluting used is not the same as that cited in the Bill of Material, the dimensions of the affected packaging and packing materials will be adjusted accordingly."
