MANUALS, TECHNICAL: COMMERCIAL EQUIPMENT

This interim amendment is issued for use by the Department of the Air Force with Military Specification MIL-M-7298C dated 1 November 1970.

Page 4, paragraph 3.1.2.8.2.3: Commercial Parts. Delete (ALL) and substitute (A, N, MC, DSA).

Page 4, add new paragraphs as follows:

3.1.2.8.3. <u>Cross Reference Listings for Illustrated Parts Breakdowns</u>. (F) The Illustrated Parts Breakdowns of any commercial manual selected for use by the Government shall be supplemented to provide a cross-reference listing which relates the Commercial Producer (Installed) part number to the True Vendor part number to the Item of Supply part number. The source, maintenance and recoverability(SMR) code shall also be listed.

*3.1.2.8.3.1 Format. (F) The IPB cross-reference listing shall be arranged in the following format. The width of the columns shall be adjusted to accommodate the information.

3.1.2.8.3.2 Original Equipment Manufacturer (OEM) Part Number Column. (F) This column shall contain the part number assigned by OEM for a part installed in a delivered product. If an OEM's part number is not assigned, leave the column blank.

3.1.2.8.3.2.1 <u>FSCM Column</u>. (F) The appropriate FSCM for the OEM (Installed) part number shall be listed in this column directly opposite each part number listed in the OEM part number column.

3.1.2.8.3.3 <u>True Vendor Part Number Column</u>. (F) This column shall contain the part number assigned by the vendor who actually produced the part. (This shall be the part number documented to the Government in the initial provisioning process.)

3.1.2.8.3.3.1 <u>FSCM Column</u>. (F) The appropriate FSCM for the True Vendor part number shall be listed in this column directly opposite each part number listed in the True Vendor part number column.

3.1.2.8.3.4 Item of Supply Part Number Column. (F) This column shall contain the part number that is stocked, stored and issued by the Government as the item of supply as identified by the Government during the initial provisioning process. The True Vendor and Item of Supply part numbers may or may not be identical. No entry shall be made in this column when the Item of Supply part number is identical to the True Vendor part number.

3.1.2.8.3.4.1 <u>FSCM Column</u>. (F) The appropriate FSCM for the Item of Supply part number shall be listed in this column directly opposite each part number listed in the Item of Supply part number column.

*3.1.2.8.3.5 Source Maintenance and Recoverability (SMR). This column shall contain the five digit Joint Military Services Uniform SMR Codes and/or the Air Force Peculiar the Being" Source and Repair Codes assigned by the Government and furnished by the procuring activity. When codes are not available for publication in the initial issue, scheduled changes or revisions, as applicable, shall incorporate SMR codes approved by the Government during the initial provisioning process.

Page 5, paragraph 3.2.1: Delete and substitute:

"3.2.1 Identifying Technical Publication Sheet. (N, MC, F, DSA) An identification sheet shall be prepared and supplied by the contractor and shall identify the commercial manual and any supplemental technical data provided. The identifying technical publication sheet shall be supplied when the commercial manual is partially acceptable but supplemental data must be provided and when the commercial manual is acceptable as written but is not identified with a publication number and date furnished by the procuring activity. When the commercial manual is acceptable, as written, and requires no supplemental technical data, but is not identified with a publication number and date supplied by the procuring activity, the identifying technical publication sheet shall be prepared in accordance with Figure 1. When supplemental data must be supplied to make the commercial manual complete or adequate, an identifying technical publication sheet shall be prepared in accordance with Figure 2."

Page 15, Figure 6: Delete Sheet 1 of Figure 6 and substitute new Sheet 1 as shown in Attachment 1 to this amendment.
