MILITARY SPECIFICATION

POWDER, PROPELLANT, CORDITE N

This amendment forms a part of Military Specification MIL-P-17449(NOrd) dated 29 October 1953, and has been approved for use by the Naval Ordnance Systems Command, Department of Navy.

By this amendment, MIL-P-17449(NOrd) is changed to MIL-P-17449(OS).

1. Page 2, paragraph 2.2, delete in its entirety and substitute:

"2.2 Other publications. The following document forms a part of this specification to the extent specified herein. Unless otherwise indicated, the issue in effect on date of invitation for bids shall apply.

49 CFR 171-178 Hazardous Materials, Regulations, Department of Transportation

(Applications for copies of the above publication should be addressed to Superintendent of Documents, Government Printing Office, Washington, D. C. 20402.)"

2. Page 3, sub-paragraph 3.2.3 - change "(see 6.1)," to "(see 6.2)".
3. Page 3, sub-paragraph 3.3.1 - change "See 6.1", to "(see 6.2)".
4. Page 15, delete sub-paragraph 6.1 and subsequent entries, and add:

"6.1 Use - The propellant covered by this specification is intended for use as a propelling charge for guns.

6.2 Ordering Data - Procurement documents should specify:

6.2.1 Procurement requirements.

- a) Title, number, and date of the specification
- b) Type of grain (see 1.2)
- c) Percent of potassium sulfate or other flash eliminating salt to be added (see 3.2.3).
- d) Process approval (3.3.1).
- e) Information concerning government material furnished.

- f) Information on inspection and acceptance conditions.
- g) That the safety precaution requirements of the Contractor's Safety Manual for Ammunition, Explosives and Related Dangerous Material, DOD 4145.26M, are applicable.

NOTE: When this specification is used as part of the description of work to be accomplished by a Government activity, the safety precaution requirements of Ammunition Ashore, OP 5, should be made applicable."

6.2.2 Contract data requirements. Items of deliverable data required by this specification are cited in the following paragraphs herein:

DIDS (Data Item Descriptions/DD Forms 1664) for the above data requirements are/will be (*) documented in the applicable ADL (Authorized Data List).

Such data will be delivered as identified on completed (numbered) DIDS when specified on DD Forms 1423 (Contract Data Requirements Lists) and incorporated into applicable contracts.

6.3 In case the powder fails to pass the ballistic tests in the weapon for which it was intended, the Naval Ordnance Systems Command may, if deemed to its interest, accept the powder, upon its meeting the specifications for any other weapon."
