This specification is approved for use by all Departments and Agencies of the Department of Defense.

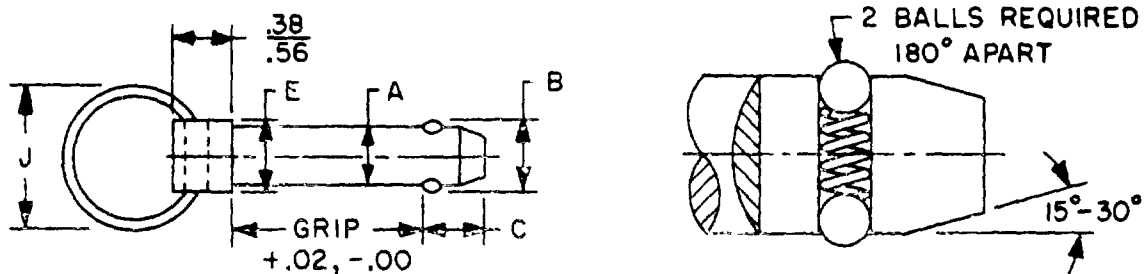

3. Dimensions - All dimensions are in inches.
4. Part number consists of M45952/1, a dash number taken from Table I and a second dash number which specifies the grip length in tenths of an inch. Example: M45952/1-4-08; Alloy steel pin, 1/4 inch nominal diameter and a grip length of 0.8 inch.
5. Use for shear applications only.
